About This Compendium

This document compiles published press coverage related to Rosie's Law — a legislative and advocacy effort founded by Dr. Tameer Siddiqui in response to a personal experience that revealed a profound gap in Illinois law: the treatment of companion animals as property rather than sentient beings with emotional bonds and welfare needs.

Rosie — a senior Puggle whose forced separation from her primary caregiver sparked national media attention — became the catalyst for HB4540, the Companion Animal Custody Equity Act. The bill has advanced through the Illinois Senate Judiciary Committee and is proceeding to a second reading, representing a historic milestone in companion animal law.

The articles gathered here were published independently across multiple national media outlets between November 2025 and the present. Together, they document both the human story behind *the Initiative* and the broader legal and emotional case for reform.

Rosie, a senior Puggle with warm brown eyes and a gentle, trusting nature, spent most of her life in the care of one person — Tameer Siddiqui, the woman who fed her, trained her, groomed her, protected her, and loved her as family. For years, Tameer was not just part of Rosie's world — she was Rosie's world. Daily walks, medical appointments, routines built around comfort, emotional support, and a home filled with stability became the center of Rosie's life. But when Tameer's engagement ended, everything Rosie knew vanished overnight.

A Family Bond Erased by an Outdated Law

Despite being Rosie's primary caregiver for the majority of the dog's life, Tameer discovered that in Illinois, her devotion meant little in the eyes of the law. Because she and her former partner were not married, Rosie was not treated as a sentient being with a clear attachment and emotional needs — she was viewed strictly as property under Illinois' replevin statute.

Even though the former partner could not prove ownership beyond old veterinary records and social-media photos, and despite Tameer presenting extensive documentation of caregiving, the court still ruled against her. Witness affidavits from Rosie's groomer, sitter, and neighbors were dismissed as 'hearsay' simply because these individuals had to return to work before the delayed hearing was called.

In barely thirty minutes, the judge handed Rosie back to the person who had not been her primary caregiver for years — invoking 'sequence,' the idea that whoever originally acquired the pet automatically maintains possession. That single decision shattered a deeply bonded relationship.

A Call for Reform

Today, Tameer is speaking publicly so others don't experience the same devastating loss. Her mission is to push Illinois toward compassionate, modern pet-custody laws that recognize animals as sentient beings, consider caregiving, attachment, and welfare, protect bonds formed outside marriage, and prevent emotionally traumatic separations.

When we talk about family, pets are often at the center of that definition. They're not just animals — they're companions, emotional anchors, and, for many people, chosen family. Yet in the eyes of the law, pets continue to be treated as property. And as one Illinois woman recently learned, that classification can carry devastating consequences.

Her story begins with Rosie — a sweet, energetic Puggle who had been her closest companion for more than seven years. She raised Rosie, trained her, paid for her medical care, and documented every stage of her growth. To her, Rosie was not 'a pet.' She was family.

But when her engagement ended, she discovered a painful truth: because she and her partner were not legally married, the state of Illinois did not recognize her right to even argue for custody of the dog she had cared for every day. Under Illinois law, pet-custody considerations apply only to married couples going through divorce. Unmarried partners — even those who have spent years sharing responsibility, love, and daily care — are excluded entirely.

The Emotional Toll on Rosie

What makes the situation even more troubling is that Rosie suffers from severe separation anxiety. She depended on her primary caregiver for emotional stability — something any behavioral specialist could attest to. Yet the court declined to consider Rosie's psychological well-being. For those who understand animal behavior, this wasn't just a legal oversight; it was an act of harm.

Research consistently shows that pets experience emotional distress, grief, and attachment in ways that parallel human bonds. Losing a primary caregiver can lead to anxiety, depression, and even physical symptoms in animals.

A National Problem

Although a few states — including California, Alaska, and Illinois (but only for married couples) — have introduced pet-custody laws that consider an animal's best interest, the majority of the country still lags behind. In a society where people are delaying marriage or choosing not to marry at all, laws built around outdated family structures fail to recognize modern relationships and leave countless animals vulnerable.

Rosie's story is not unique. It mirrors the experiences of countless pet guardians across the country who have lost their animals not because they were unfit, but because the law refused to acknowledge the depth and legitimacy of their bond.

- Extend pet-custody protections beyond married couples to all domestic partners and co-habiting caregivers
- Require courts to consider the best interest of the animal — including established bonds and primary caregiving history
- Treat companion animals as sentient beings, not personal property, in custody disputes
- Close the legal gap that currently leaves unmarried caregivers with no recognized rights

The petition complements HB4540's legislative progress and serves as a direct line for public engagement with *the Initiative*. Every signature represents a person who believes that love — not paperwork — should determine where a companion animal belongs.

ABOUT THE INITIATIVE

Rosie's Law Initiative

Rosie's Law Initiative is an Illinois-based legislative and public advocacy campaign founded by Dr. Tameer Siddiqui, a licensed clinical psychologist and the primary caregiver at the center of the case that inspired it. The Initiative's central legislative vehicle is HB4540 — the Companion Animal Custody Equity Act — which recently passed the Illinois Senate Judiciary Committee and is advancing to a second reading.

The Initiative advocates for a legal framework in which companion animals are recognized as sentient beings with emotional needs, established attachments, and welfare interests — not merely as items of personal property to be divided in disputes. It seeks to extend the caregiving-centered protections currently available only to married couples under Illinois law to all caregivers, regardless of marital status.
